



Terms & Conditions - (this list is not exhaustive)

- The restaurant is a non-smoking area with a designated outdoor smoking area on the outside pool deck and lawn areas.
- All beverages including wine, spirits, mineral water, coffee and tea are charged as per the restaurant beverage list.
- We have a wide selection of wines available for consumption and guests may bring their own Wines at a corkage rate of R100 a bottle.
- A 50% deposit is required in order to secure your event. Send in the completed booking form and once finer details are confirmed and invoiced, please send confirmation of payment to restaurant@valdevine.co.za. Only then will the event be confirmed. No venue fee applicable to non-exclusive events.
- Special requests that require hiring of extra linen or equipment will be for the client's own account and will reflect on the final Invoice. If damage or loss occurs to these hired items, Val De Vine will not take responsibility for the replacement or fixing costs incurred.
- No advertising banners are allowed to be displayed on the property. Only if you have exclusivity of the Val De Vine restaurant, are you allowed to display your banners within the restaurant.
- Cancellation of event:
 - a. If the event is cancelled 6 months prior to the event date, the full deposit will be refunded.
 - b. If the event is cancelled less than 3 months to the event date, the deposit will be refunded in full only if the date is rebooked with another event.
- Final numbers for all events to be confirmed at least one week prior to the event.
- All estimated costs for food, beverages and 15% service/setup fee is to be settled on the day of your event.
- All decorations and hired equipment to be picked up no later than 09h00 the following day. Due to limited storage space, ensure hired items are only delivered after 16h00 the day before the event. Only Val De Vine furniture to be used for events.
- Our kitchen is not Halaal or Kosher certified, all our suppliers are Halaal certified and can cater for Halaal friendly options. Strict Halaal and Kosher meals can be ordered in for the client on request. There is an additional surcharge which will be quoted per person upon request.
- Our menu is seasonal and does change according to product availability as such the pricing is subject to change.

- All Liquor sales & events are to conclude no later than 23h00 in accordance with our Liquor license.
- Music levels are to be reduced to background level at 22h00. All music to conclude no later than 23h00 as to not disrupt inhouse guesthouse guests.
